

# SELLERS DEAERATOR AND BFS WARRANTY INCLUDING FIFTEEN YEAR TANK WARRANTY

#### I. GENERAL

Sellers Manufacturing Company warrants this Deaerator to be free of defects in materials and workmanship. This warranty is extended to the original owner-user of the products subject to time periods, exceptions, conditions, and limitations stated in this warranty.

#### II. PARTS WARRANTY- EIGHTEEN MONTHS

Sellers will replace or repair any component part originally supplied with this Deaerator that becomes defective during the first eighteen (18) months from date of shipment. Labor costs to replace defective parts are not covered by this warranty.

#### III. TANK WARRANTY- FIFTEEN YEARS

Sellers Mfg. guarantees the Deaerator with an Epoxy-Phenolic lining, against leakage for a period of fifteen (15) years from the date of shipment. This warranty covers leakage due to corrosion or cracks in steel parts or welds of the tank. The warranty has a full warranty period and a prorated warranty period as follows:

- 1. **First through Fifth Year- Full Warranty**-If a leak should develop in the tank during the first 60 months from the date of shipment, Sellers will repair the leak in the tank or furnish a replacement tank, at its option, at no charge to the owner. The warranty will not cover freight or installation charges for a replacement tank.
- 2. Sixth through Fifteenth Years-Prorated Warranty-If a leak should develop in the tank from the start of the 60<sup>th</sup> month to the end of the 180<sup>th</sup> month from the date of shipment. Sellers will furnish a replacement tank to the owner for the current list price for the replacement tank times the pro rata fraction. The pro rata fraction will be determined by the number of months from the date of shipment of the deaerator to the date of order of the replacement tank divided by 180 months. The warranty will not cover freight or installation charges for the replacement tank.

## IV. EXCEPTIONS

This warranty does not cover defective components or damage resulting from:

- 1. Injecting damaging chemicals into deaerator. (Many chemicals cause pump damage).
- 2. Unauthorized welding to the tank or extending parts after the Epoxy-Phenolic lining has been applied.
- 3. Failure to replace sacrificial magnesium anodes every year or more frequently or as required.
- Improper installation
- 5. Failure to comply with Federal, State, or local codes.
- 6. Fires, floods, earthquakes, freezing, acts of God, accidents or misuse whether willful or not.

## V. CONDITIONS

- 1. The owner must notify Sellers in writing, addressed to Box 48, Danville, Kentucky 40423-0048, of any claim covered by this warranty within thirty (30) days after discovery of the defect or failure.
- 2. Shipment of warranty replacement parts will normally be made by United Parcel Ground Service or Parcel Post at Sellers expense. Whenever size of weight of the replacement part required struck shipment or the owner requests shipment by air or other special means, shipment will be made at the owner's expense with freight charges collect whenever possible.
- 3. The replacement parts will be invoice to the owner at the current retail price plus and prepaid freight charges. To be eligible for warranty credit, the owner must return the defective parts to Sellers Mfg. with the freight charges prepaid. If inspection of the defective part by Sellers confirms the warranty claim, full credit for the invoice will be issued. United Parcel Ground Service or Parcel Post shipping charges for the replacement parts will also be credited. Charges for shipment by other means are to be paid by the owner.

## VI. LIMITATIONS

- 1. SELLERS MFG. RESERVES THE RIGHT TO DETERMINE WHETHER DEFECTIVE OR DAMAGED COMPONENTS COVERED BY THIS WARRANTY WILL BE REPLACED OR REPAIRED AND WHETHER NECESSARY REPAIRS WILL BE MADE BY THE FACTORY PERSONNEL OR INDEPENDENT CONTRACTORS. REPAIRSS NOT SPECIFICALLY AUTHORIZED BY SELLERS MFG. AND REPLACEMNT PARTS NOT FURNISHED BY SELLERS MFG. WILL NOT BE COVERED BY THIS WARRANTY.
- 2. THIS WARRANTY DOES NOT COVER ANY LABOR FOR THE REMOVAL OF DEFECTIVE PARTS, RETURNING DEFECTIVE PARTS FOR CREDIT, OR INSTALLING REPLACEMENT PARTS.
- 3. REPLACEMENTS ARE WARRANTED ONLY FOR THE REMAINDER OF THE PERIOD PROVIDED FOR IN THE ORIGINAL WARRANTY.
- 4. SLLERS MFG WILL NOT ASSUME LIABILITY FOR INCIDENTAL OR CONSEQENTIAL DAMAGES OR EXPENSES DUE TO COMPONENT OR TANK FAILURES. THE SOLE REMEDY UNDER THIS WARRANTY IS REPAIR OR REPLACEMENT AS STATED.
- 5. THERE IS NO WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE.
- 6. THERE ARE NO OTHER WARRANTIES WHICH EXTED BEYOND THE DESCRIPTION OF THE FACE HEREOF.
- 7. THIS WARRANTY IS NOT VALID UNLESS THE SPECIFIC INFORMATION CALLED FOR BELOW IS PROVIDED AND IT HAS BEEN SIGNED BY AN OFFICER OF SELLERS MFG.
